- Black Diamond sealcoated and striped the asphalt
- Basketball hoop and pole installed
- Replacing bulbs on 26 light poles with LED bulbs and replacing all plastic panels in each fixture
- Repaired crack in the monument wall
- Removed dead trees and trimmed 23 trees
- Applied free mulch received from the Village
- Purchased two trees through the Village's 50/50 program

Projects Planning To Do:

- Replace roof
- Replace east and west windows in the indoor pool
- Replace spa heater
- Diamond Brite indoor pool

## V. TREASURER'S REPORT

Paulette Wirkus stated that the assessments will remain at \$82 for 2016. The Board has budgeted \$80,000 to be added to the Reserve Fund. 80% of funds collected are used for maintaining the facility and property. 20% of the funds are used for the Reserve Fund.
