## ANNUAL BOARD MEETING

Wednesday, September 19th at 7:00 p.m.

The purpose of the Annual Meeting will be the election of one Member of the Association to the Board of Directors for a three-year term. If you would like to run for this Board position, contact the Clubhouse for a Candidate Information Form. The completed Form must be returned to the Clubhouse to be reviewed by the Nominating Committee by **Monday, August 27th**. Write-in candidates may be nominated from the floor.

The Board position that is up for election this year is currently held by the Association's President, Shawn Rodgers. He has served as President for four years and has been on the Board of Directors for five years.

## **POOL RULE /ID CARD REMINDERS**

- All guests must be accompanied by a resident.
- No strollers or other wheeled vehicles are allowed in the Pool Area.
- Radios or other open speaker electroic equipment are prohibited in the Pool Area or the Patio Area.
- Children not toilet trained are permitted in the wading pool only.
- Food is allowed in the Patio Area only.
- Only drinking water in a plastic container is allowed in the Pool Area.
- All assessments must be current before using Clubhouse facilities.
- After you turn in your ID card to the attendant at the pool, the bracelet that you're given must be worn on your wrist.
- Resident children under 14 years of age, with an ID card, shall be accompanied by an adult, at least 18 years of age, during the entire time they are in the Pool Area. The adult may be a Guest with a Guest ID card pertaining to the resident child's family.
- Resident children 14 years of age or older may use the outdoor pool without adult supervision and may bring guests 14 years of age or older.

### **NEW GUEST CARD RULES**

The current By-Laws allow residents to "borrow" up to 6 Guest Passes from other residents for their use. The Board approved the availability of up to 12 total Guest Passes that could be issued daily by the Clubhouse attendant instead of "borrowed" passes. These Club Guest Passes will be issued on a first-come first-serve basis and are valid for only the day of issue. A resident may use his/her 2 Guest Passes and up to 6 Club Guest Passes to bring in a total of up to 8 guests. "Borrowed" passes may not be used at the same time as the Club Guest Passes. A log of passes will be kept.

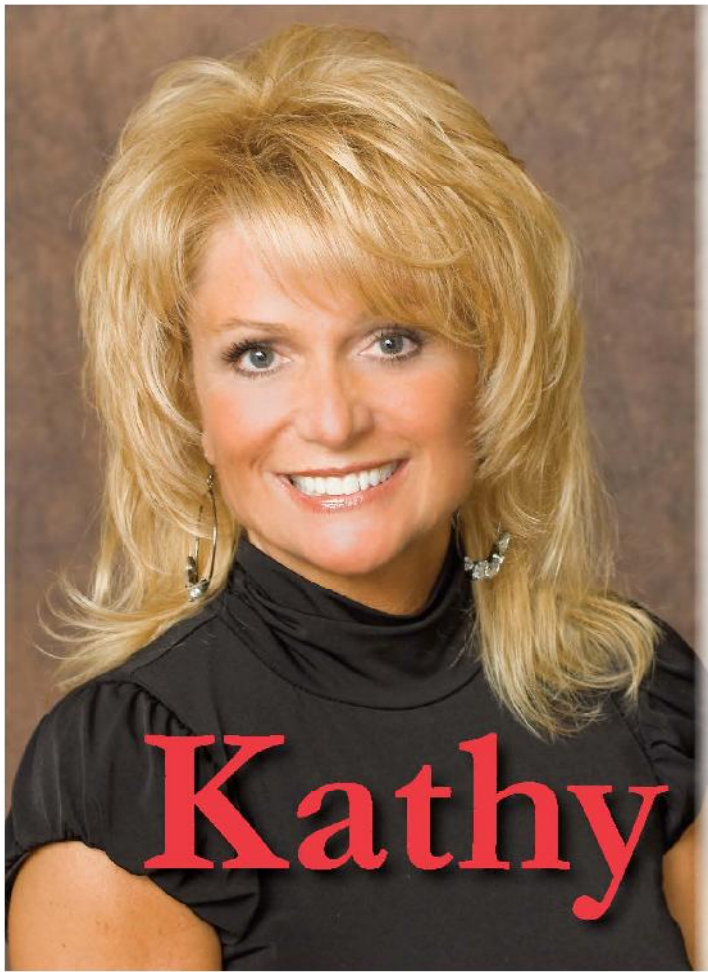
The purpose of this meeting is to elect one Director and to transact all other business that may come before the Membership.
