POSSIBLE TEMPORARY INDOOR POOL CLOSING

The dehumidification system in the indoor pool has failed. The Board has received only one bid to replace the system. Two other contractors are submitting bids within the next couple of weeks.

If the outside temperature increases over a period of time before the system is replaced, significant and damaging humidity will be created in the indoor pool. To avoid that damage, the indoor pool would need to be closed until the new dehumidification system is installed.
