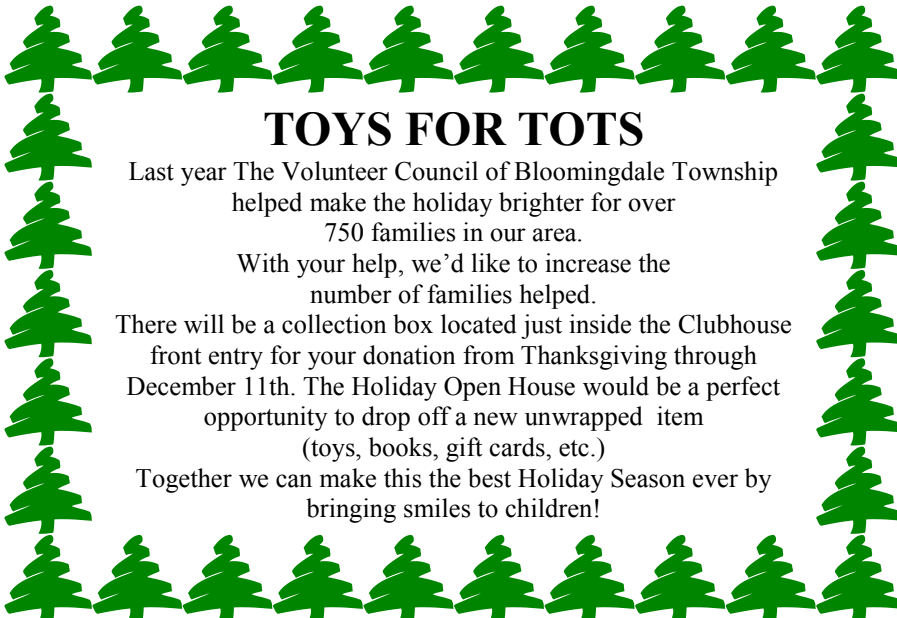
Come to the Clubhouse and have a FREE picture taken of your child with Santa.

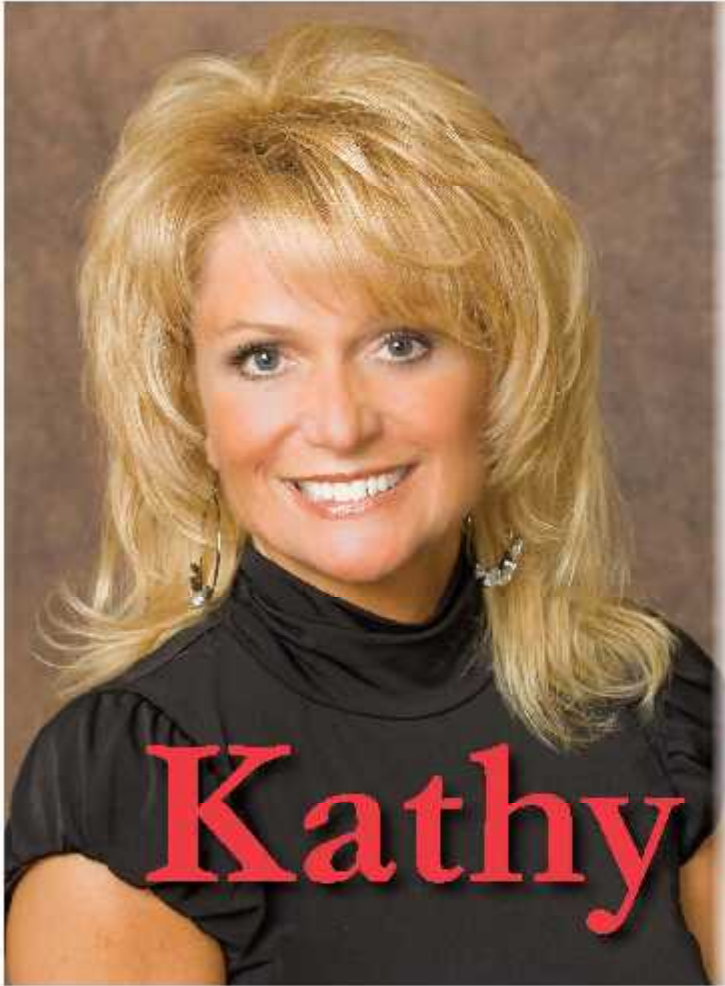
