ANNUAL MEETING

- ◆ Hired Valley Insulation to install R60 insulation in the Clubhouse attic, which will lessen energy expenses.
 - ◆ Completed the video security system, installing additional cameras overlooking the outdoor and indoor pool area, the front entry and the inner lobby. Altogether, 14 new cameras were installed.
 - ◆ Hired Paveman to sealcoat the walking path.
 - ◆ Hired Sherwin Painting to paint the outdoor pool fence and hired them to paint sections of the perimeter fence that have had major damage.
 - ◆ Purchased a recumbent bicycle from Body Solid for the Exercise Room.
 - ◆ Hired Keith Refurnishers to refinish/refurbish various pieces of furniture and the staircase.
 - ◆ Hired Just Add Water to replace the aerator in the retention pond.
 - ◆ Hired Bright Metal Maintenance to refinish the letters on the entry walls.

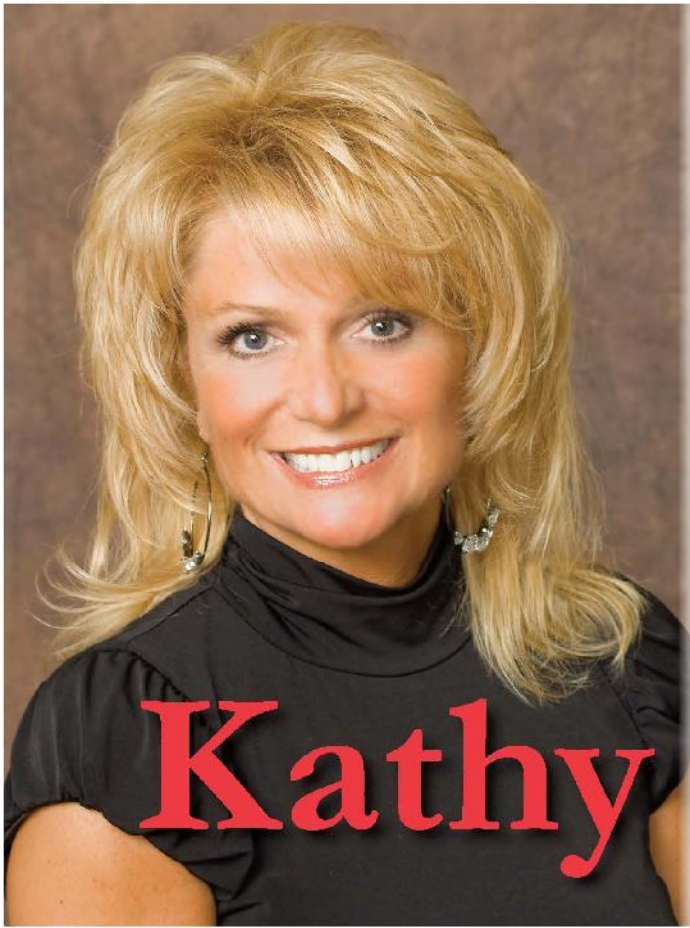
